



# **UNAA (NSW) UNITED NATIONS CENTRE FOR EDUCATION**

Education about the United Nations and its activities empowers people of all ages with the knowledge, skills, values and attitudes to address the interconnected global challenges we are facing today, including climate change, environmental degradation, loss of biodiversity, poverty, and inequality.

The UNAA (NSW) United Nations Centre for Education (UNCE) has been successful in driving progress towards achieving Sustainable Development Goal 4: Quality Education and all of the 17 SDGs. Created to help address sustainable development challenges across Australia and beyond, it provides the knowledge, skills, attitudes, and necessary values.

### The UN Diploma

The UNAA (NSW) UN Diploma is one of the ways that UNAA (NSW) is achieving its goal of promoting and celebrating the work of the UN. Our educational programs are key to sustainable change and equip students with the knowledge, training and confidence needed to become global citizens. This educational program sits at the heart of our United Nations Centre for Education.

This course helps to ensure that business leaders, academic staff, other professionals, and interested members of the public are better equipped with the necessary skills to effect positive change, such as achieving the aims of the SDGs.

During 2021/2022, the UNAA (NSW) ran two courses, which have to date inspired and engaged over 200 individuals across Australia, giving them the opportunity to become more aware of the history and structure of the United Nations, and the work that is happening locally in NSW to help achieve UN aims. Leaning on our values of inclusion, diversity and equity, we offered scholarship places to enable students from all backgrounds and lived experiences to apply. We encourage people who have experienced greater barriers to opportunities to apply, especially women, LGBTIQIA+ people, Aboriginal and Torres Strait Islanders, people with disabilities, people from culturally diverse backgrounds, and younger people.

### The UN Day School Program - Peace People Planet

The UNAA (NSW) established its 'United Nations Day ~ Peace People Planet' initiative to promote awareness and education in schools about the work of the UN, the 2030 Agenda for Sustainable Development and contribute to UNESCO's 'Education for Sustainable Development' objectives.

Supported by the NSW Department of Education, over 24 public and private primary and secondary schools participated in our Peace People Planet initiative. In total, 1500 students worked at school on curated resources and SDG campaign booklets at school provided by the UNAA (NSW). For some, this was an opportunity for students and staff to be introduced to the SDGs and the UN's goals and objectives.

Teachers integrated the material into topical lessons and adapted it to the different levels from Years 1-10. In Years 7-10, material about the SDGs was integrated into History, Geography and Science classes for research and discussion purposes. In Science classes, students particularly enjoyed building their very own water filters, with many not realising how many people around the world don't have everyday access to clean water.

This initiative was also an opportunity for students to discover and celebrate UN Day at school by engaging in a wide range of UN-related topics. Activities included creative challenges to promote the SDGs and a 'Blue Day' which encouraged students to wear blue clothing on UN Day.

Schools received a Certificate of Participation along with a complimentary one-year UNAA (NSW) Organisational membership, and student work was showcased to mark the International Day of Education on 24 January 2022.

# **UNITED NATIONS DAY 76**

### 22 - 24 October 2021

UN Day, celebrated each year on or around the 24th of October, gives us the opportunity to underline UN shared values and common agendas and reaffirm the purpose and principles of the UN Charter that have guided us over the past 76 years. UNAA (NSW) marks this important annual occasion with a UN Day commemorative wreath-laying service, a Gala Dinner, and through the awarding of our prestigious UN Day Honour.

This year, UNAA (NSW)'s UN Day Commemorative Wreath Laying Service, which normally takes place at the Cenotaph in Martin Place, Sydney, was held virtually due to COVID-19 restrictions. The online Service distributed messages from the UNAA (NSW) President, our Patron the Governor of NSW Her Excellency the Honourable Margaret Beazley AO QC, and distinguished guest speaker, Major General Cheryl Pearce AM, former Force Commander in Cyprus.

This Ceremony appropriately recognised all those who have laid down their lives in the service of peace and for the protection of communities in conflict zones all over the world.

The service was once again successfully coordinated by Event Lead and Life Member, Mr Geoffrey Little, who has been the organiser for 28 years, with support from UNAA (NSW) Director of Peace & Security and Vice President (Ops), Major General (Retired) Tim Ford AO.

While the Gala Dinner was unfortunately postponed due to COVID-19, a highlight of UN Day this year was the announcement of our 2021 UN Day Honour Recipient.

This award was created to recognise individuals or organisations in Australia that have made a significant contribution to the aims and objectives of the UN, for example in promoting peace, respect for human rights, equal opportunities, social justice and environmental sustainability.

We were delighted to announce that Landcare Australia was selected as the recipient of the 2021 United Nations (UN) Day Honour. This award is in recognition of Landcare Australia's embodiment of the UN values of sustainable development and strong track record of supporting community-led, on-ground projects to restore, enhance and protect Australia's unique natural environment. Their bold vision of "all Australians actively caring for the land and water that sustains us" empowers individuals across Australia to build more resilient ecosystems and communities.

2021 marks the start of the UN Decade on Ecosystem Restoration, a call to prevent, halt the degradation of ecosystems around the world and drive their protection and revival for the benefit of people and nature. The Decade will run to 2030, which is also the deadline for the Sustainable Development Goals (SDGs) and the timeline identified by scientists for preventing catastrophic climate change.

In recognition of this important decade and UNAA (NSW) current focus on Agenda 2030 awareness and sustainable development, special consideration was given to nominees with a strong track record of achievement in the areas of ecosystem restoration, protection of biodiversity and Caring for Country. We look forward to partnering with Landcare Australia to realise these important UN aims.

Landcare Australia will be formally presented with the Honour at the 2022 United Nations Day Gala Dinner, to be held at NSW Parliament House on Friday 21 October 2022.

# THE UN DECADE ON **ECOSYSTEM RESTORATION**

The 2030 Agenda for Sustainable Development seeks to end poverty, conserve biodiversity, combat climate change and improve livelihoods for everyone, everywhere. These objectives, encapsulated in the 17 SDGs, are unlikely to be met unless ecosystem degradation is stopped and ecosystem restoration is undertaken at the immense scale of hundreds of millions of hectares globally.

NOTABLE FINDINGS INCLUDE AMONG MANY OTHERS:



Three-quarters of the land-based environment and about 66% of the marine environment have been significantly altered by human actions. On average these trends have been less severe or avoided in areas held or managed by Indigenous Peoples and Local Communities.



75%

More than a third of the world's land surface and nearly 75% of freshwater resources are now devoted to crop or livestock



33%

In 2015, 33% of marine fish stocks were being harvested at unsustainable levels; 60% were maximally sustainably fished, with just 7% harvested at levels lower than what can be sustainably fished.



64,000

In Australia, the Great Barrier Reef has lost half of its corals since 1995 due to bleaching events. This poses a threat to 64,000 jobs and the AUD 6.4 billion the reef brings to the Australian economy mostly from tourism, but also from fishing, recreational and scientific activities.

Insufficient political support and technical capacity in both the public and private sectors hinder investment in the many hundreds of thousands of ecosystem restoration initiatives worldwide that are needed to achieve restoration at such a scale. Not only would such investment contribute to achieving the SDGs, but it would also yield considerable economic returns for a recovery from the COVID-19 crisis and lead to more social, economic and ecological resilience.

UN Member States decided to implement a Decade on Ecosystem Restoration to realise these benefits and to ensure that healthy ecosystems play a critical role towards achieving the SDGs by 2030.

### **RAISING PEACE FESTIVAL**

Raising Peace is an alliance of more than 30 organisations that together work to share ideas, knowledge and inspiration for a peaceful world. In September 2021 it held its first Peace Festival. 37 events were held by over 30 organisations working for peace in Australia. The Raising Peace Festival explored the significance of peace to First Nations people, women, youth, refugees and the environment. It looked at the different ways we define and understand peace, from the absence of war to peacekeeping and peacemaking. The festival was a great success, with over 1,050 participants across all the events.

UNAA (NSW) strongly supported the festival through the organisation and two events it hosted on September 21 the International Day of Peace. These events inspired us to think creatively and collectively about how to help everyone recover better, how to build resilience and how to transform our world into one that is more equal, more just, equitable, inclusive, sustainable, and healthier.

### SEPTEMBER (ONLINE)

THEME: International Day of Peace. Speakers included UNAA (NSW) VP Ops Tim Ford AO, Dean Parkin Director at From the Heart and Abigail Kaplan, Executive Producer at Order in the House Podcast as they discussed the meaning of the UN Day International Day of Peace.



### **UNAA NSW PEACE ACTION WEBINAR**

The webinar was presented by UNAA (NSW) Vice President (Ops), Major General (Retired) Tim Ford AO, who was previously a UN Head of Mission and Military Advisor in UN Peacekeeping. It covered a range of topics, including the Department of Peace Operations and the Department of Political and Peacebuilding Affairs. We also held a post-webinar activity on Youth and Peace - the purpose of which was to interact with the online platform Padlet and answer the question "How can young people contribute to the UN and its role 'to maintain international peace and security?". Discussions in the breakout rooms involved a diverse input of opinions and experiences.



# **HUMAN RIGHTS**

The Human Rights Pillar aims to uphold the UN's core objective of protecting and respecting human rights. It does this by raising awareness of the Universal Declaration of Human Rights in Australia, and reinforcing the importance of a diverse, inclusive, more equitable Australian community.

### THE NATIONAL ANTI-RACISM FRAMEWORK

In 2021 the Australian Human Rights Commission has launched a plan to develop a National Anti-Racism Framework. The Framework will be a long-term, central reference point to guide actions on anti-racism for government, NGOs, business, educators, health professionals, police, other justice authorities, civil society, and the community. The UNAA (NSW) collaborated in the shaping of the draft and discussed its alignment to the United Nations SDGs and the Universal Declaration of Human Rights.

### **NAIDOC WEEK**

We celebrated NAIDOC Week 2022 by screening the film Ablaze, a feature documentary during a very special NAIDOC Week Members and Volunteers Meetup. The film tells the story about Bill Onus a Yorta Yorta Wiradjuri man from Victoria who was a heroic cultural and political figure that revived his people's culture in the 1940s, and ignited a civil rights movement that would, against all odds, change the course of history. Guest speakers included Ken Zulumovski, Director, Gamarada Universal Indigenous Resources, and Wes Trist, President, Mob Sydney Aboriginal Motorcycle Club.





### **HUMAN RIGHTS DAY 2021 - ONE VOICE, ONE HUMANITY**

To celebrate Human Rights Day 2021, UNAA (NSW) in partnership with the Centre for Social Justice and Inclusion (UTS) and Affinity Intercultural Foundation, curated a 2 hour online programme which brought together voices from a variety of communities to shed light on the complexity of the Human Rights issues, create awareness of the challenges, and highlight the ongoing achievements. The diversity of voices from Indigenous, multicultural, refugee, youth, ageing, disability, and LGBTQIA+ communities aim to showcase our shared humanity and reaffirm the importance of Human Rights both within Australia and internationally.

The main topics were: Embracing our common humanity, pivoting the impact of COVID-19, the future of Human Rights, and the intersection of sports and Human Rights. One Voice, One Humanity featured Australian of the Year Craig Foster, Senator Mehreen Faruqi, and performances by the acclaimed Bangarra Dance Company, and many more.

### **VESAK DAY**

We were honoured to again partner with Henry Dang, Hon Secretary-General of the Buddhist Federation of Australia to mark the UN Vesak Day and commemorate the birth, enlightenment and death of Buddha. With a global reach, Prime Minister The Hon Scott Morrison MP, and the Leader of the Opposition, The Hon Anthony Albanese MP, conveyed messages and UNAA (NSW) President Dr Patricia Jenkings delivered the UN Secretary General's message.



# SUSTAINABLE DEVELOPMENT

The key focus of the Sustainability Pillar is to promote a sustainable planet, where the needs of the present are met without compromising the ability of future generations to meet their own needs. Its focus is to raise awareness of the 2030 Agenda and support the Australian community to take climate action and transition to net zero carbon emissions by 2050.

Using the adopted Collective Impact framework to act as a backbone organisation for Corporates, Government agencies, and Nonprofits to work together to advance the SDGs, this year, UNAA (NSW) has been focusing on building meaningful partnerships especially social media campaigns to promote the UN International days: Global goals week, World Food Day, World Wildlife Day, World Water Day, Earth Day, International Day for Biological Diversity, World Environment Day and World Oceans Day.



### THE BANKSIA FOUNDATION 2021 NSW SUSTAINABILITY AWARDS

The UNAA (NSW) partnered with the Banksia Foundation to promote the inaugural 2021 NSW Sustainability Awards. The awards recognise and celebrate trailblazers who are driving progress on the SDGs from circular transition to net zero action to our state's young climate champions. The Hon Matt Kean, Treasurer and Minister for Energy and Environment presented the awards.



### **Note 1: Summary of Significant Accounting Policies**

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act 2009. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accrual basis and are based on historical costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies have been adopted in the preparation of these financial statements.

### a)Revenue and Other Income

Interest revenue is recognised using effective interest method, which for floating rate financial assets is the rate inherent in the instrument.

Grant and donation income is recognised when the association obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

### b) Accounts Payable and Other Payables

Accounts payables and other payables represent the liability outstanding at the end of the reportingyear for goods and services received by the association during the reporting year that remain unpaid. The balances are recognised as a current liability and the amounts are normally paid within 30 days of recognition of the liability.
